All shares of the Issuer's Class A Common Stock and Class B Common Stock held indirectly by the Reporting Persons were canceled for no consideration in connection with the merger (the Merger) of Viacom Merger Sub Inc. with and into Viacom Inc. (Viacom), with Viacom as the surviving corporation of the Merger. On the date of the Merger, the Issuer changed its name from New Viacom Corp. to Viacom Inc., and beginning January 3, 2006, began regular way trading (VIA; VIA.B).

2. These securities are owned directly by Viacom Inc. (Viacom), but may also be deemed to be beneficially owned by (1) NAIRI, Inc. (NAIRI), which owns approximately 71% of Viacom's voting stock, (2) NAIRI's parent corporation, National Amusements, Inc. (NAI) and (3) Sumner M. Redstone, who is the controlling stockholder of NAI.
