Viacom Declares Quarterly Cash Dividend

(NASDAQ: VIAB and VIA) today announced that its Board of Directors has declared a quarterly cash dividend of \$0.20 per share on both its Class A and Class B common stock. The dividend will be payable on April 3, 2017 to stockholders of record at the close of business on March 15, 2017.
