Explanation of Responses:

On December 16, 2021, the closing price of the Class B common stock on The NASDAQ Global Select Market was \$29.74 per share.
- These shares were withheld by ViacomCBS to satisfy tax liability incident to the vesting of, and delivery of shares underlying, the RSUs, and were not actually sold or otherwise disposed of in an open-market transaction.
- Granted under ViacomCBS's long-term incentive plan for no consideration.
